

Rules of participation in the conference

- I. In order to participate in conferences organized by Projekt Avant, a scientific association based in Bydgoszcz, 85-866, Zofii Nałkowskiej Street 12/19, NIP: 9532786514, REGON: 520522552, it is necessary after receiving acceptance of the application to register by providing the required data and paying the conference fee (unless otherwise specified) by the date indicated in the conference notice. Applications are accepted by the organizers in accordance with academic policies.
- II. Full refund of the fee is possible only up to 14 days before the date of the conference. From 13 to 7 days before the date, only a partial refund (50%) is possible. After this date, refunds are no longer available. Reimbursement is available upon written request of the participant, submitted via e-mail: projekt.avant@avant.edu.pl
- III. By registering his/her participation in the conference, Participant(s) provides his/her personal data, which will be used exclusively for the organization of the conference, and at the same time:
- 1) she/he agrees to the processing of the provided personal data in accordance with:
- (a) Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (RODO),
- (b) the Act of May 10, 2018 on the protection of personal data, Journal of Laws. 2018 item 1000;
- 2) he/she agrees to the possible online transmission of his/her conference presentation, as well as to the recording of his/her image in the form of photos and videos from the conference, which will be published in the online conference archive of the Projekt Avant;
- 3) she/he declares that she/he has read the following information clause:
- a) in accordance with Article 13(1) and (2) of RODO*, we inform you that the Administrator of the personal data of the Participants is Project Avant, which can be contacted by post (the above address) and e-mail: projekt.avant@avant.edu.pl,
- b) the Data Protection Supervisor can be contacted by email: projekt.avant@avant.edu.pl,
- c) the received personal data of the Participant will be processed to the extent necessary for the organization and conduct of the conference,
- d) data storage period: from the date of receipt until the thirtieth day after the end of the conference;
- e) the recipient of the personal data is the Project Avant,
- f) In accordance with the RODO, the conference Participants are entitled to:
- The right to access their own personal data and receive a copy of it,
- The right to rectify (amend) their own personal data,
- The right to erasure of their own personal data in case the processing of such data does not take place for the purpose of fulfilling a legal obligation,

- The right to restrict the processing of one's own personal data,
- The right to object to the processing of one's own personal data
- The right to lodge a complaint to the President of the Office for Personal Data Protection (to the address of the Office for Personal Data Protection, 2 Stawki Street, 00-193 Warsaw, Poland),
- g) Provision of the required personal data is voluntary, however, failure to provide such data will result in inability to participate in the conference.
